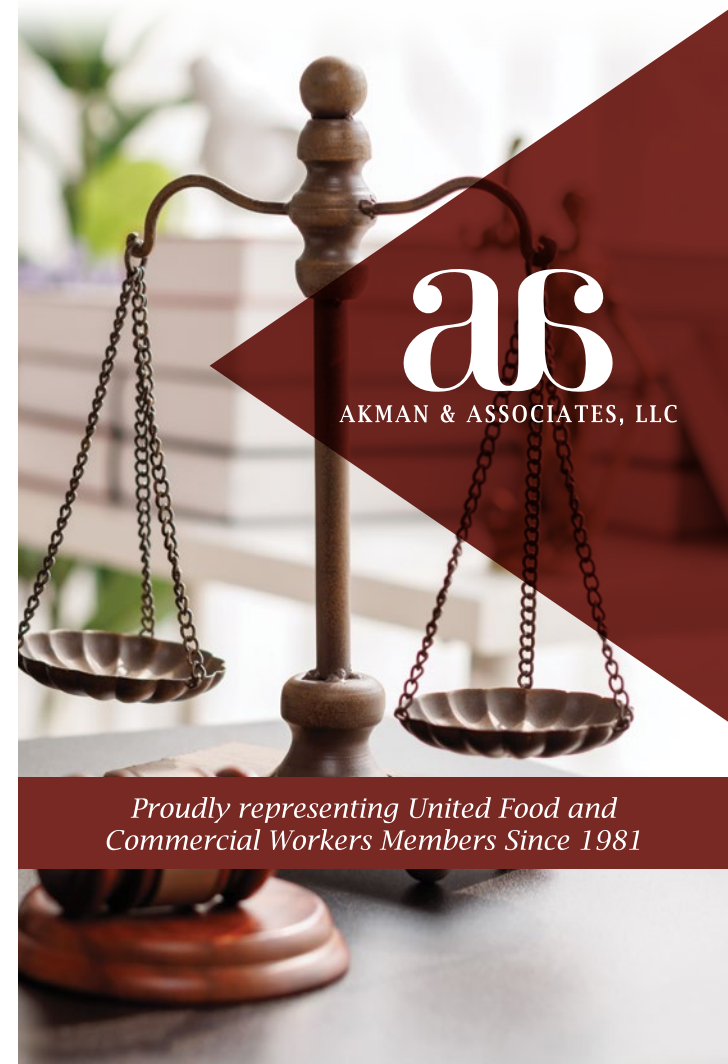

SCHEDULE OF BENEFITS

The following benefits are available to all eligible participants and to dependents.

PLAN A – Part Time Participants

1. Unlimited Advice and Consultation.

2. Plan offices will be open from 9:00 a.m. to 5:00 p.m. Monday through Friday, excluding legal holidays. Special arrangement can be made for those Participants who cannot visit the office during normal business hours.

3. Preparation of Last Will and Testament

- a. For the Participant and spouse of the Participant
- b. Consultation and advice on the appropriate type of Last Will and Testament
- c. Codicils or other amendments for the Last Will and Testament

4. Preparation of Simple Legal Documents

- a. General Power of Attorney
- b. Contract for the sale or purchase of personal property
- c. General Release
- d. Authorization for the release of information, etc.
- e. Change of Name

5. Review and Explanation of Legal Documents

6. Administrative Law

- a. Social Security Disability Application
- b. Social Security Disability Reconsideration

Includes all Covered Benefits in Plan A, in addition the following:

1. Real Estate Matters

- b. Review and preparation of contract for the sale or purchase of the Participant's primary residence.
- c. Representation as tenant in landlord and tenant disputes involving primary residence.
- d. Assistance in application for homestead exemption where applicable.

2. Civil Consumer Litigation

- a. Defense in the State's lowest court of initial jurisdiction (including court appearance):
 1. Excessive interest and late charges
 2. Debt collection actions
